Results of operations for the 13 weeks ended 26 August 2017

Revenue

Revenue increased by 5.9% to £259.9m in the 13 week period ended 26 August 2017 and increased by 3.6% to £513.3m in the 26 week period ended 26 August 2017 (13 week period ended 27 August 2016: £245.5m; 26 week period ended 27 August 2016: £495.6m; 52 week period ended 25 February 2017: £1,037.3m).

Cost of sales and gross profit

Cost of sales increased by 3.3% to £230.2m in the 13 week period ended 26 August 2017 and increased by 1.2% to £453.9m in the 26 week period ended 26 August 2017 (13 week period ended 27 August 2016: £222.9m; 26 week period ended 27 August 2016: £448.3m; 52 week period ended 25 February 2017: £925.7m).

Gross profit increased by 31.4% to £29.7m in the 13 week period ended 26 August 2017 and increased by 25.6% to £59.4m in the 26 week period ended 26 August 2017 (13 week period ended 27 August 2016: £22.6m; 26 week period ended 27 August 2016: £47.3m; 52 week period ended 25 February 2017: £111.6m).

Gross profit as a percentage of revenue increased to 11.4% in the 13 weeks ended 26 August 2017 and increased to 11.6% in the 26 weeks ended 26 August 2017 (13 week period ended 27 August 2016: 9.2%; 26 week period ended 27 August 2016: 9.5%; 52 week period ended 25 February 2017: 10.8%).

Administrative expenses (including exceptional items)

Administrative expenses (including exceptional items) increased by £0.1m to £14.7m in the 13 week period ended 26 August 2017 and increased by £0.2m to £30.6m in the 26 week period ended 26 August 2017 (13 week period ended 27 August 2016: £14.6m; 26 week period ended 27 August 2016: £30.4m; 52 week period ended 25 February 2017: £65.5m).

Exceptional items of £0.2m were incurred in the 13 week period ended 26 August 2017 and £0.8m in the 26 week period ended 26 August 2017 (13 week period ended 27 August 2016: £0.2m; 26 week period ended 27 August 2016: £0.2m; 52 week period ended 25 February 2017: £0.7m income).

Operating profit

Operating profit pre exceptional items increased by £7.0m to £15.2m in the 13 week period ended 26 August 2017 and increased by £12.5m to £29.6m in the 26 week period ended 26 August 2017 (13 week period ended 27 August 2016: £8.2m; 26 week period ended 27 August 2016: £17.1m; 52 week period ended 25 February 2017: £47.9m).

Net finance costs (including exceptional items)

Net finance costs (including exceptional items) decreased by £0.2m to £9.4m in the 13 week period ended 26 August 2017 and decreased by £0.7m to £18.7m in the 26 week period ended 26 August 2017 (13 week period ended 27 August 2016: £9.6m; 26 week period ended 27 August 2016: £19.4m; 52 week period ended 25 February 2017: £36.2m).

Exceptional finance income of £nil occurred in the 13 week period and the 26 week period ended 26 August 2017 (13 week period ended 27 August 2016: £nil; 26 week period ended 27 August 2016: £nil; 52 week period ended 25 February 2017: £2.5m).

Results of operations for the 13 weeks ended 26 August 2017 (continued)

Taxation

Taxation in the 13 week period ended 26 August 2017 was a £0.6m charge and the 26 week period ended 26 August 2017 was £1.7m charge (13 week period ended 27 August 2016: £0.1m charge; 26 week period ended 27 August 2016: £0.1m charge; 52 week period ended 25 February 2017: £2.5m charge).

Profit/loss for the period

The profit in the 13 week period ended 26 August 2017 was £5.0m and the profit in the 26 week period ended 26 August 2017 was £8.4m (13 week period ended 27 August 2016: £1.7m loss; 26 week period ended 27 August 2016: £2.6m loss; 52 week period ended 25 February 2017: £7.4m profit).

Cash flow

Cash flows from operating activities increased by £4.3m to £40.0m in the 13 week period ended 26 August 2017 and increased by £15.9m to £56.2m in the 26 week period ended 26 August 2017 (13 week period ended 27 August 2016: £35.7m; 26 week period ended 27 August 2016: £40.3m; 52 week period ended 25 February 2017: £81.9m).

Net cash used in investing activities was £8.2m in the 13 week period ended 26 August 2017; £14.5m in the 26 week period ended 26 August 2017 (13 week period ended 27 August 2016: £5.2m; 26 week period ended 27 August 2016: £11.7m; 52 week period ended 25 February 2017: £26.6m).

Net cash used in financing activities was £nil in the 13 week period ended 26 August 2017 and the 26 week period ended 26 August 2017 (13 week period ended 27 August 2016: £nil; 26 week period ended 27 August 2016: £nil; 52 week period ended 25 February 2017: £9.4m used).

Cash increased by £31.6m in the 13 week period ended 26 August 2017 and increased by £22.5m in the 26 week period ended 26 August 2017 (13 week period ended 27 August 2016: £29.3m increase; 26 week period ended 27 August 2016: £8.6m increase; 52 weeks ended 25 February 2017: £6.6m increase). The cash balance as at 26 August 2017 was £103.6m.

1. General information

The Company is incorporated and domiciled in Guernsey, all subsidiary companies are incorporated and domiciled in the UK. The Company is limited by shares. The financial statements are presented in sterling, which is the Group's functional and presentational currency. The Group's principal place of business is Perimeter Road, Knowsley Industrial Park, Liverpool, L33 7SZ.

These condensed consolidated interim financial statements were approved for issue on 9 October 2017.

2. Summary of accounting policies

Basis of preparation

These condensed consolidated interim financial statements should be read in conjunction with the annual financial statements for the 52 weeks ended 25 February 2017, which have been prepared in accordance with International Financial Reporting Standards (IFRS) as adopted by the European Union and IFRIC interpretations.

Except as described below, the accounting policies applied are consistent with those of the annual financial statements for the 52 weeks ended 25 February 2017, as described in those annual financial statements.

Taxes on income in the interim periods are accrued using the tax rate that would be applicable to expected total annual earnings.

There are no new IFRSs or IFRIC interpretations that are effective for the first time for this financial period that would be expected to have a material impact on the Group.

At the date of approval of these condensed consolidated interim financial statements, the IASB and IFRIC have issued new or amended standards and interpretations which were in issue but not effective for the financial period and not early adopted. The adoption of these standards is not expected to have a material impact on the Company's accounts when adopted, except where stated:

4. Segment Reporting

The chief operating decision-maker has been identified as the Board of Directors. The Directors consider there to be one operating and reportable segment, being that of the sale of clothing and homewares through out of town retail outlets, primarily through the Matalan fascia, in the United Kingdom.

Internal reports reviewed regularly by the Board provide information to allow the chief operating decision-maker to allocate resources and make decisions about the operations. The internal reporting focuses on the Group as a whole and does not identify individual segments. This set of condensed consolidated interim financial statements is therefore presented as a single reportable segment.

The chief operating decision-maker relies primarily on EBITDA before exceptional items to assess the performance of the Group and make decisions about resources to be allocated to the segment. This can be reconciled to statutory operating profit as follows:

The effective annual income tax rate of 21.1% for the period is higher than the standard rate of corporation tax in the UK of 19.0% at the end of August 2017 (August 2016: 20.0%, February 2017: 20.0%). The key reconciling items relate to non-deductible expenses. The rate of corporation tax is based on a weighted average rate. A reduction in the UK corporation tax rate from 21% to 20% (effective from 1 April 2015) was substantively enacted on 2 July 2013.
