Results of operations for the 13 weeks ended 24 November 2018

Revenue

Revenue increased by 4.9% to £308.3m in the 13 week period ended 24 November 2018 and increased by 3.7% to £836.6m in the 39 week period ended 24 November 2018 (13 week period ended 25 November 2017: £293.8m; 39 week period ended 25 November 2017: £807.1m; 52 week period ended 24 February 2018: £1,063.0m).

Cost of sales and gross profit

Cost of sales increased by 8.7% to £261.8m in the 13 week period ended 24 November 2018 and increased by 4.8% to £728.1m in the 39 week period ended 24 November 2018 (13 week period ended 25 November 2017: £240.9m; 39 week period ended 25 November 2017: £694.8m; 52 week period ended 24 February 2018: £927.0m).

Gross profit decreased by 12.1% to £46.5m in the 13 week period ended 24 November 2018 and decreased by 3.4% to £108.5m in the 39 week period ended 24 November 2018 (13 week period ended 25 November 2017: £52.9m; 39 week period ended 25 November 2017: £112.3m; 52 week period ended 24 February 2018: £136.0m).

Gross profit as a percentage of revenue decreased to 15.1% in the 13 weeks ended 24 November 2018 and decreased to 13.0% in the 39 weeks ended 24 November 2018 (13 week period ended 25 November 2017: 18.0%; 39 week period ended 25 November 2017: 13.9%; 52 week period ended 24 February 2018: 12.8%).

Administrative expenses (including exceptional items)

Administrative expenses (including exceptional items) decreased by £1.3m to £14.4m in the 13 week period ended 24 November 2018 and decreased by £1.8m to £44.5m in the 39 week period ended 24 November 2018 (13 week period ended 25 November 2017: £15.7m; 39 week period ended 25 November 2017: £46.3m; 52 week period ended 24 February 2018: £63.9m).

Exceptional items of £nil were incurred in the 13 week period ended 24 November 2018 and £0.3m in the 39 week period ended 24 November 2018 (13 week period ended 25 November 2017: £0.2m; 39 week period ended 25 November 2017: £1.0m; 52 week period ended 24 February 2018: £1.8m).

Operating profit

Operating profit pre exceptional items decreased by £5.3m to £32.1m in the 13 week period ended 24 November 2018 and decreased by £2.7m to £64.3m in the 39 week period ended 24 November 2018 (13 week period ended 25 November 2017: £37.4m; 39 week period ended 25 November 2017: £67.0m; 52 week period ended 24 February 2018: £73.9m).

Net finance costs (including exceptional items)

Net finance costs (including exceptional items) were £9.4m in the 13 week period ended 24 November 2018 and £28.0m in the 39 week period ended 24 November 2018 (13 week period ended 25 November 2017: £9.4m; 39 week period ended 25 November 2017: £28.1m; 52 week period ended 24 February 2018: £52.1m).

Exceptional finance expense of £nil occurred in the 13 week period ended 24 November 2018 and the 39 week period ended 24 November 2018 (13 week period ended 25 November 2017: £nil; 39 week period ended 25 November 2017: £nil; 52 week period ended 24 February 2018: £14.8m).

Taxation

The taxation charge in the 13 week period ended 24 November 2018 was £5.4m and in the 39 week period ended 24 November 2018 was £8.3m (13 week period ended 25 November 2017: £5.7m; 39 week period ended 25 November 2017: £7.4m; 52 week period ended 24 February 2018: £5.2m).

Results of operations for the 13 weeks ended 24 November 2018 (continued)

Profit for the period

The profit in the 13 week period ended 24 November 2018 was £17.3m and the profit in the 39 week period ended 24 November 2018 was £27.7m (13 week period ended 25 November 2017: £22.1m; 39 week period ended 25 November 2017: £30.5m; 52 week period ended 24 February 2018: £14.8m).

Cash flow

Cash flows from operating activities decreased by £21.6m to £20.7m in the 13 week period ended 24 November 2018 and decreased by £14.4m to £84.2m in the 39 week period ended 24 November 2018 (13 week period ended 25 November 2017: £42.3m; 39 week period ended 25 November 2017: £98.6m; 52 week period ended 24 February 2018: £121.2m).

Net cash used in investing activities was £9.1m in the 13 week period ended 24 November 2018 and £32.5m in the 39 week period ended 24 November 2018 (13 week period ended 25 November 2017: £41.1m; 39 week period ended 25 November 2017: £55.7m; 52 week period ended 24 February 2018: £72.8m).

Net cash used in financing activities was £nil in the 13 week period ended 24 November 2018 and the 39 week period ended 24 November 2018 (13 week period ended 25 November 2017: £nil; 39 week period ended 25 November 2017: £nil; 52 week period ended 24 February 2018: £19.2m).

Cash increased by £9.7m in the 13 week period ended 24 November 2018 and increased by £29.0m in the 39 week period ended 24 November 2018 (13 week period ended 25 November 2017: £0.9m decrease; 39 week period ended 25 November 2017: £21.6m increase; 52 weeks ended 24 February 2018: £18.9m decrease). The cash balance as at 24 November 2018 was £91.2m.

Notes to the financial statements (continued)

1. General information

The Company is incorporated and domiciled in Guernsey, all subsidiary companies are incorporated and domiciled in the UK. The Company is limited by shares. The financial statements are presented in sterling, which is the Group's functional and presentational currency. The Group's principal place of business is Perimeter Road, Knowsley Industrial Park, Liverpool, L33 7SZ.

These condensed consolidated interim financial statements were approved for issue on 14 January 2019.

2. Summary of accounting policies

Basis of preparation

These condensed consolidated interim financial statements should be read in conjunction with the annual financial statements for the 52 weeks ended 24 February 2018, which have been prepared in accordance with International Financial Reporting Standards (IFRS) as adopted by the European Union and IFRIC interpretations, and specifically IAS 34 Interim Financial Reporting.

Except as described below, the accounting policies applied are consistent with those of the annual financial statements for the 52 weeks ended 24 February 2018, as described in those annual financial statements.

Taxes on income in the interim periods are accrued using the tax rate that would be applicable to expected total annual earnings.

There are no new IFRSs or IFRIC interpretations that are effective for the first time for this financial period that would be expected to have a material impact on the Group.

At the date of approval of these condensed consolidated interim financial statements, the IASB and IFRIC have issued new or amended standards and interpretations which were in issue but not effective for the financial period and not early adopted. The adoption of these standards is not expected to have a material impact on the Company's accounts when adopted, except where stated:

New standards, amendments to standards or interpretations

• IFRS 16 Leases. The new standard is effective for annual reporting periods beginning on or after 1 January 2019. The impact of the new standard is expected to be material and is currently under review by the Group.

The transition to IFRS 16 will impact the financial statements, affecting the income statement, statement of financial position and disclosures when adopted, including the opening statement of financial position at 24 February 2019. The new standard allows for two different transition approaches, fully retrospective and modified retrospective. The initial phase of work undertaken by the Group has concluded on the decision to adopt the modified transition approach. The Group is still in the process of assessing the impact of the new standard, which cannot yet be fully quantified.

The Group intends to adopt the new standards and amendments no later than their applicable date, subject to endorsement by the EU.

4. Segment Reporting

The chief operating decision-maker has been identified as the Board of Directors. The Directors consider there to be one operating and reportable segment, being that of the sale of clothing and homewares through out of town retail outlets, primarily through the Matalan fascia, in the United Kingdom.

Internal reports reviewed regularly by the Board provide information to allow the chief operating decision-maker to allocate resources and make decisions about the operations. The internal reporting focuses on the Group as a whole and does not identify individual segments. This set of condensed consolidated interim financial statements is therefore presented as a single reportable segment.

The chief operating decision-maker relies primarily on EBITDA before exceptional items to assess the performance of the Group and make decisions about resources to be allocated to the segment. This can be reconciled to statutory operating profit as follows:

The performance of the Group is subject to seasonal peaks. The Group traditionally performs well during the late spring and early summer and over the Christmas season.

Whilst the e-commerce business represents a significant opportunity for future growth within the Group, it does not yet represent a significant portion of the operating results of the Group. E-commerce is therefore not reported as a separate operating segment by the Group for internal or external reporting purposes.

5. Income tax

Income tax for the 13 week period ended 24 November 2018 is charged at 23.8% and for the 39 week period ended 24 November 2018 is charged at 23.1% (13 weeks ended 25 November 2017: 20.5%; 39 weeks ended 24 November 2017: 19.5%; 52 weeks ended 24 February 2018: 26.0%) of profit representing the best estimate of the effective annual income tax rate expected for the full year, applied to the pre-tax profit for the 13 week and 39 week periods.

The effective annual income tax rate of 23.1% for the period is higher than the standard rate of corporation tax in the UK of 19.0% at the end of November 2018 (November 2017: 19.0%, February 2018: 20.0%). The key reconciling items relate to non-deductible expenses. The rate of corporation tax is based on a weighted average rate. A reduction in the UK corporation tax rate from 21% to 20% (effective from 1 April 2015) was substantively enacted on 2 July 2013. Further reductions to 19% (effective from 1 April 2017) and to 18% (effective 1 April 2020) were substantively enacted on 26 October 2015, and an additional reduction to 17% (effective 1 April 2020) was substantively enacted on 6 September 2016.

Borrowings are all denominated in sterling at 24 November 2018. The Group had no short-term borrowings during any of the reported periods. Issue costs of £6.2m were incurred in relation to the First Lien Secured Notes and Second Lien Secured Notes and are being amortised over the terms of the facilities.

A proportion of the Second Lien Secured Notes are held by shareholders of the Company.

We may from time to time seek to retire or purchase our outstanding debt through cash purchases in open market purchases, privately negotiated transactions or otherwise. Such repurchases, if any, will depend on prevailing market conditions, our liquidity requirements, contractual restrictions and other factors. In the 52 week period ending 24 February 2018 the Group issued £350m First Lien secured notes due 2023 and £130m Second Lien unsecured notes due 2024. The proceeds of this offering were used to refinance in full the existing bond issues. Further details can be found in note 14.

During a previous period a lease previously assigned to another retailer was returned to the Company in 2009 on privity of contract after they entered administration. A provision was created at that time to recognise that the lease was onerous and this was treated as exceptional in nature and is being released over the remaining life of the lease.

During a previous period, the Group established a provision for anticipated future dilapidations costs, this was fully utilised within the period ending 24 February 2018.

9. Acquisition of NCI

In the prior year, the Group acquired an additional 25% interest in Matalan Direct Limited under its historic obligations for £0.4m in cash, increasing its ownership from 75% to 100%. The carrying amount of Matalan Direct Limited's net liabilities in the Group's financial statements on the date of acquisition was (£3.7m). The Group recognised a decrease in NCI of £0.9m and a decrease in retained earnings of £1.3m.

13. Related party transactions
